The St. Moritz Ice Skating Club (SMISC) is committed to creating a safe and positive environment for members' physical, emotional and social development and ensuring that it promotes an environment free of misconduct.

Members of the St. Moritz Ice Skating Club are expected to conduct themselves in an acceptable and responsible manner at all times at all figure skating events or activities. All club members are expected to exhibit good sportsmanship, show respect, and be courteous toward the skaters, coaches, parents/guardians of skaters, U.S. Figure Skating officials, and guests.

Members registering with the SMISC do so knowing and accepting the expected code of conduct. All members will adhere to the U.S. Figure Skating rules and all Safesport policies and procedures of U.S. Figure Skating and the St. Moritz Ice Skating Club.

By signing below I hereby agree that:

- 1. I will encourage good sportsmanship by my actions, demonstrating positive support for all skaters, parents/quardians, coaches, and officials.
- 2. I will encourage safe and healthy skating environments by maintaining a respectful and courteous attitude to others.
- 3. I will not ridicule, bully, blame, or yell at any skaters, coaches, officials or volunteers for any reason.
- 4. I will treat skaters, coaches, parents/guardians, fans, volunteers, officials, and rink staff with courtesy and respect, regardless of race, creed, color, sexual orientation or ability. I will also take action and report any acts of bullying, harassment or abuse to the appropriate authorities.
- 5. I will strive to resolve conflicts calmly and peacefully without resorting to hostility or violence.
- 6. I will demand a figure skating environment that is free of drug or alcohol abuse and agree that I will not use or provide to a third-party any illegal drug prohibited by applicable federal, state, or municipal law.
- 7. I will not assist or condone any athlete's use of a banned substance as described by the International Olympic Committee, International Skating Union, United States Olympic Committee, or U.S. Figure Skating, or, in case of athletes, to use such drugs or refuse to submit to properly conducted drug tests administered by one of these organizations.
- 8. I will show appreciation and recognize the importance of club volunteers. I will fulfill my responsibility to help my club with membership, special projects, competitions, test sessions and any other club-related on or off the ice activities.
- 9. I agree to report to the appropriate entity/party any SafeSport or Code of Conduct violations that I observe.
- 10. I will become familiar with the rules of the U.S. Figure Skating and act accordingly.
- 11. I will support and respect all skaters and their right to participate.
- 12. I understand that violations of the code of conduct may result in disciplinary actions up to and including expulsion from the SMISC.
